PATH TO HEALTH SUSPENDS THE REDETERMINATION OF BENEFITS

Path to Health members that required a renewal in June 2020, were automatically granted an extension until August 31, 2020. Path to Health members that require a renewal in July 2020 were also automatically granted an extension until August 31, 2020. ***No action is required on the part of clinics, application assistants or members.*** New Path to Health ID cards reflecting the revised enrollment end dates will be mailed to members. Path to Health will continue to extend eligibility terms until the end of the COVID-19 Public Health Emergency.
